**4. To approve Planning applications as notified by the District Council
Ref 09/01849/1**

Land at Baldock Radio Station – Royston Road Wallington – change of use of land to provide new race horse training facilities comprising 42 stables including feed, tack storage and office, two storage barns one equine pool with plant room, solarium and sandroll, one warm up track, one horse exerciser and one six furlong gallop. Associated staff accommodation comprising one trainers house, one assistance trainers house and one two beds staff hostel. Associated works access tracks and widening of the existing vehicular crossover on to A505.

The only concern to be raised to NHDC is the proposed widening of the vehicular access on the A505 as this junction is already quite blind and if larger slower vehicles are to cross this could be very dangerous.

5. Door Step Green– to consider the proposals of the committee

It was agreed that the name of the project would be changed to Amenity project and the bank account renamed Amenity account to reflect the fresh start for the project.

A consultation will be put out to the Village to seek opinion on what facility would be desired. Cllrs Hills and Kingsbury volunteered to set up a sub committee for this and will seek to recruit other members from the Village.

6. Amenity area – To review the lease. report of fly tipping and to approve cutting of the hedge

It was noted that the lease comes up for renewal in April 2010 and an approach will be made to the land owner to see if she is willing to renew this lease and under what terms.

Cllr Patterson will put together some notices and letters to draw peoples attention to the offence of fly tipping .

Some standard Bye - laws will be explored through HAPTC.

Cllr Hills and Cllr Culpin will undertake the repairs to the gate of the field and the grounds contractor will be approached to cut the edge of the field around the trees.
