Outline Application: Mixed use development comprising up to 2,800 dwellings, a new local centre, two primary schools and a secondary school, a healthcare hub, up to 1,900sqm of 'A' Class land uses (including a supermarket), open space, nature conservation, recreation, landscaping and associated facilities, following demolition of existing structures and vehicular access - outline planning application with all matters reserved other than access.

Land East Of North Road And North Of The Railway Line, Bygrave Road, Baldock, Hertfordshire,

The application described above has recently been received by the Council.

I should be interested to know if you have views, either for or against the proposal, which you would like the Council to consider before it makes a decision on the application. If so, to ensure they are taken into account, please let me have them in writing by 16 March 2018, which is 8 weeks from the date of this letter (this is an extended consultation period in addition to the usual statutory period of 3 weeks).

This planning application relates to a strategic site allocated within the Emerging North Hertfordshire Local Plan 2011-2013 (site reference BA1, which falls under emerging Policy SP14 of the Local Plan). The Local Plan is currently going through the 'Examination in Public' process and has not yet been adopted. A major planning application of this nature has a statutory determination period of 16 weeks. However, owing to the scale of the proposals and the link with the Emerging Local Plan (noted above), the consideration of this application is likely to take place over an extended period of time. The Council's website will be updated with any extensions of time on the determination date.
